# THE 2023 STATE BUDGET

With the state budget carers awaited news about increases to their payments. Alas, the 2023 budget disappointed once again - there were no ongoing increases to carer payments. Statutory carers were awarded a \$650 one-off bonus which was well received. However, one-off payments are not as helpful as an ongoing increase in payments.

Also concerning are the ongoing cuts to the public service, with a further 4000 jobs cut from across the whole public service.

Prior to the budget, KCV issued a statement forewarning of the unsatisfactory consequences of not supporting carers sufficiently well and on wider community wellbeing due to cuts to the public service.

After the budget, KCV wrote to all Victorian politicians in protest at the lack of due consideration of kinship carers and calling on MPs to make connection with kinship carers in their electorates to listen to carers' stories of financial hardship. As MPs respond KCV is making appointments to brief them. A letter to MPs in the Australian Government was also sent. The letter urged national action to strengthen the public sector across the nation.

KCV is also seeking the inclusion of kinship carers in the Australian Carers Recognition Bill. This will give the recognition necessary to urge better support for carers across the country.

Work to secure financial support for kinship carers via a range of avenues proceeds, with KCV stepping up efforts to get some relief for kinship carers in relation to the cost of education.

Carers have also been encouraged to sign the FCAV petition. Other activities leading up to Budget 2024 are being planned.

# **EDUCATION INVESTIGATION**

The Victorian Commissioner for Children and Young People is undertaking a review of education outcomes for children and young people in out-of-home care. The costs of education as a barrier to full participation in education has repeatedly come into discussions in the many consultations the Commissioner's office has conducted. The report of this investigation is due to be released in November.

KCV has partnered with the Commissioner's office to sponsor an art exhibition supporting this review.
