

About GPV/KCV

In April 2001, Grandparents Victoria (GPV) was formed as an organisation based on the belief that grandparents can play a valuable role in supporting and advocating for families and the wider community and promoting the value of the public sector. At this early stage, with only four members at the first meeting, it was not clear what action the group would take, or how its activities were to be funded, but enthusiasm was high.

For the first two years, GPV focused on consultation with grandparents to learn what challenges they and their families were facing. A series of forums were also held across Victoria to collect different many opinions. Since then, regular forums and surveys have been conducted to verify these early views.

In March 2002, the issues faced by grandparents raising their grandchildren were noted, with the GPV Board deciding that the role of grandparents within child protection would be a priority area of work.

Another landmark was reached in 2004 when GPV staff attended the organisation's first local grandparents support group. This was the first of many visits to support groups across the state. In 2010 the Department of Health and Human Services (DHHS) awarded GPV the contract to establish Kinship Carers Victoria (KCV) as the peak group representing the views of kinship carers.

GPV/KCV addresses a wide range of issues. Some issues, aside from support for kinship carers, appear on its work program year in and year out, with family poverty being the most urgent of all the issues addressed over the years.

GPV/KCV is committed to an ethical approach to its work, undertaking to:

- maintain a commitment to its beliefs and aims, prioritising the wellbeing of families
- always maintain confidentiality, protecting the privacy of all who associate with GPV/KCV
- uphold individual rights and advocate for the rights of disadvantaged groups
- foster a culture of fairness

GPV/KCV believes that:

- all children must be protected and given every opportunity and support to fulfil their potential
- the needs of families are becoming more complex and the support grandparents can offer to families in general is significant
- grandparents and kinship carers have unique understandings and attitudes that should influence decisions about child wellbeing
- grandparents and kinship carers have a responsibility to engage in public discussions and to act to ensure the wellbeing of children

Privacy Guarantee

GPV/KCV securely stores and manages personal information shared through all forms of communications with the organisation. No personal information is ever shared with any other agency, including DFFH or any other government agency. When survey reports are completed the personal data of participants is destroyed.

Governance and Management

Board members

There were 12 Board members for the 2023-24 financial year. Foundation members, who are members of the Board since its first meeting, and shorter-term members have the same rights and responsibilities.

Overall attendance at Board meetings was higher than required by the GPV/KCV Standing Orders. However, one Board member (K Mannix) resigned when she found that her increased hours of paid work conflicted with her Board duties. The Board rates of attendance to Board meetings within 23-24 FY (4) were:

Board members, who set the direction of the agency, contributed at least 190 hours attending decision making meetings.

A highlight for the Board

Board members enjoyed a far-ranging discussion with the Minister Blandthorn. The discussion focused on the needs of children in the early years and explored ways to improve support for family preservation. There was much talk about the influential power of grandparents within families and the underdeveloped role they play in family preservation before children are removed from parents' care. Also, discussed was the widespread incidence of mental ill health amongst young people.



The Support and Advice Service


KCV provides a counselling and advice service to kinship carers. The issues raised through this program are referred to the Board, and discussed with DFFH and other agencies. In 23-24 the service was characterized by an increase in the number of agencies that made contact on behalf of carers. Sometimes the agency wanted to know about the support KCV offered but at others the agency was calling for information about levels of carer payments and wanting KCV to process carers claims. There was an increase in confusion about the role of DFFH, funded agencies and KCV. Some callers were new to their role with no previous experience in child protection.




Contacts from agencies calling on behalf of kinship carers

Publications

The GPV/KCV publications program continues to rely on both printed and electronic distribution of resources to carers. However, prohibitive cost of printing prevents mass printing runs of resources.

Websites updates and visits (99,664 total visits across 3 websites)

The websites were updated weekly and continued to increase in popularity with the number of people visiting each site being:

Podcasts and transcripts (15)

Ten new podcasts were produced. There were 1,509 listens across all podcasts for the financial year - 25% above the targets Some were part funded by Carer Kafe and others from within GPV/KCV funds. Welcome Packages (33)

Packages of written information sent to kinship carers who have connected with KCV for the first time. Thirty-three were distributed this FY. Written resources were developed in greater numbers this financial year. This work was undertaken to renew and update the Kinship Care Manual for Victoria which was somewhat out of date and never likely to be reproduced.



Face to face seminars (13)


Thirteen seminars on topical issues were delivered, they included seminars on:
