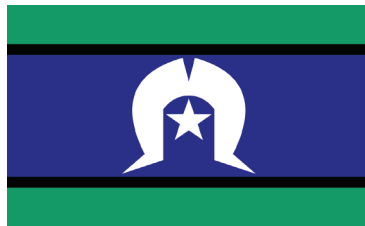

Seniors Rights Victoria supports and empowers older people through the provision of legal advice directly to the older person.

If necessary and appropriate Seniors Rights Victoria lawyers can help with:

- Intervention Orders, including requesting perpetrator be removed from a shared home
- Arrangements involving the exchange of assets in return for the promise of care including 'family care', 'assets for care' and 'granny flat' arrangements;
- Situations involving adult children living with their parents
- Financial Abuse, including debts and loans, misuse of Powers of Attorney, transfer of property and co-ownership disputes
- Disputes about contact with grandchildren
- Guardianship and Administration issues

If you or someone you know is going to court in Victoria you can use the Court Network service. Court Network is a free confidential community service provided by volunteers for all court users: victims, witnesses, accused, family and friends.

Court network telephone service hours are **12:00pm to 4:00pm Monday to Friday**

New Contact Number: **1800 571 239**

Court Network can:

- give you support and information about going to court
- explain court processes
- provide information about accessing legal support
- assist you to feel safe while at court
- help to arrange access to a secure room if required
- familiarise you with the court beforehand, so you know where to go
- provide information about how to access an interpreter
- be a support person in court
- provide support while you give your evidence in a remote witness facility
- help explain decisions that affect you
- help you with completing online applications
- refer you to other community services that can help you with legal questions, health, housing and family violence issues, as well as any other issues you may be experiencing
- advocate for your individual (non-legal) needs and circumstances at court

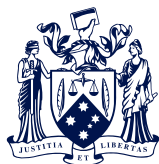
Commission for Children and Young People

- brings the views and experiences of children and young people to the attention of government and community

Find Your Lawyer Referral Service

The Find Your Lawyer Referral Service is a service provided by the Law Institute of Victoria (LIV) that gives referrals to lawyers and is able to offer support in languages other than English.

The referral will provide you with a free 30 min consultation in which no legal advice is offered. The consultation is an opportunity to discuss your legal needs, potential next steps and the fees associated with continuing. Note that any legal advice or legal work undertaken is subject to standard fees. The service offers connection with a large number of LIV members across the state covering all key areas of law

What happens after your 30 min consultation?

- Formally proceed with your matter with the selected firm
- Determine that you would like to explore more options. Through this service you may generate a total of three referrals enquiries for one legal matter

The Victorian Aboriginal Legal Service Co-operative Limited (VALS)

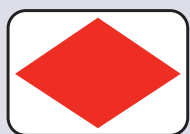

The Victorian Aboriginal Legal Service Co-operative Limited (VALS) provides localised support and referrals to community services and mainstream agencies, and works with clients to help with initial information, minor assistance such as helping with phone calls or letters, advocacy to other services, referrals, and assistance to attend court.

VALS plays an important role in providing referrals, advice/information, duty work or case work assistance to Aboriginal and Torres Strait Islander peoples in the State of Victoria. Solicitors at VALS specialise in one of three areas of law, being Criminal Law, Family Law and Civil Law. VALS' objectives are to:

- Address both the causes and effects of Aboriginal and Torres Strait Islander disadvantage. Aboriginal and Torres Strait Islander peoples experience far higher rates of adverse contact with the justice system than do other Australians. They are incarcerated at significantly higher rates than non-Aboriginal and Torres Strait Islander peoples.
- Improve access of Aboriginal and Torres Strait Islanders to high quality and culturally appropriate legal aid so they can fully exercise their legal rights as Australian citizens.
- Improve both the quality and efficiency of service delivery to the ultimate benefit of Aboriginal and Torres Strait Islander clients.
- Prioritise and target available resources to ensure that services are responsive to established policy priorities and community needs, and to provide the best possible quality of service to individual clients.

The Victorian Office of the Public Advocate (OPA) provides services to protect and promote the rights, interests and dignity of people with disability (specifically intellectual impairment, mental disorder, brain and injury or dementia) living in Victoria.

These services include guardianship, advice, education, information, research, advocacy and support and are delivered by the OPA employees and 650 OPA volunteers.

Victorian Legal Aid (VLA) provides free legal information and education with a focus on prevention and early resolution of legal problems. The VLA also provides more intense legal services such as legal advice and representation for people who meet eligibility criteria, based on their financial situation, the nature and seriousness of their problem and their individual circumstances. VLA serves the Victorian community in the following areas:

- Access and equity assisting people dealing with legal issues by ensuring that VLA services are accessible .
- Civil justice and administrative laws aim to contribute to inclusive and right-respecting community, addressing such matters as social security, mental health, guardianship and administration, infringements, immigration, tenancy, debt, discrimination, sexual harassment and victims of crime.
- Criminal law providing high-quality legal advice and representation for people charged with criminal offences who cannot otherwise afford legal assistance and who meet our eligibility criteria.
- Chambers providing advocacy for legally aided clients in civil, criminal and family, youth and children's law.
- Family law resolving family disputes and respond to state intervention to archive safe, workable and child-focused care arrangements for children. We help to build capacity to resolve future disputes with legal assistance. We also assist with family violence intervention order matters.
- Mental health advocacy to assist people on compulsory treatment orders with support and advocacy to assist them in having a say in their assessment, treatment, and recovery.

Legal Aid have lawyers on 'duty' at many courts and tribunals across Victoria. Duty lawyers can help if you are at court for a hearing, but do not have a lawyer. Where you can find our duty lawyers.

This is a free service, but not everyone is eligible. The service may also not be available every day. It's best to speak to them before you go to court.

Call 1300 792 387, Monday to Friday, from 8am to 6pm.

WHO CAN SEE A DUTY LAWYER AT COURT?

Duty lawyers help people who:

- can't afford a private lawyer
- are Aboriginal and Torres Strait Islander
- have a cognitive disability, an acquired brain injury or mental illness
- are in a psychiatric in-patient unit with a Mental Health Tribunal hearing
- are experiencing or at risk of homelessness
- are a child or young person going to the Children's Court
- can't speak, read or write well in English
- are at court for a family violence matter or are at risk of family violence
- are in custody or facing a serious penalty.
